Claiming of Amount after Transfer to IEPF:

In case you wish to claim the Amount(s) transferred to IEPF, a separate online application has to be made by the claimant to the IEPF Authority in Form IEPF-5 as prescribed under the IEPF Rules and the same is available at IEPF website i.e. <http://www.iepf.gov.in/> along with fee specified by the Authority.

The claimant, after making an application in Form IEPF-5, has to send the original copy of the same, duly signed by him/her along with requisite documents as enumerated in Form IEPF-5, for verification of his/her claim to the Company Secretary at ESAF Financial Holdings Private Limited, Second Floor, Hephzibah Complex, Mannuthy - Palakkad NH, Mannuthy, Thrissur, Kerala – 680651 and e-mail to ro@esafholdings.com
